Queensland government response







Minister's Statement

The Queensland Government is working to ensure all Queensland children and young people have access to quality school education, and the supports needed to develop a strong foundation for future education, training and employment.

As Education Minister, I oversee a diverse Queensland education portfolio covering a state school system across its eight regions, non-state schooling – both Catholic and Independent – and home education.

Home education has had a marked growth trajectory. Between 2019 and 2024, Queensland experienced the most significant growth in home education registrations of all Australian states and territories. Registrations are also dynamic, with a significant portion of families moving between home education and both schooling sectors each year.

I acknowledge the continuous work of the Home Education Unit within the Department of Education to support the growing number of home-educating families. The final report notes the impact of the growth in home education on the Home Education Unit and its capacity to oversee the regulation of, and support for, home educating families.

As in any school community, families who home educate want an educational environment to support the particular circumstances of their children. The independent Home Education Unit Review has identified improvements that will better support parents and ensure children and young people continue to access high-quality education. The review was stakeholder-informed, and its recommendations provide a pathway toward a strong and positive future for home education in Queensland.

The Government Response to the review's findings outlines the work required to address each of the recommendations. The Government Response includes the commitment to establish a permanent parent consultation and engagement body to inform Queensland's high quality home education arrangements.

I thank Ms Deborah Dunstone for leading the review and ensuring it was informed by the views of the home education community. I thank all of the home education stakeholders who participated in the review, noting in particular the commitment of the Home Education Expert Group members.

Introduction

The Queensland Government recognises the right of parents to choose school education that best meets the needs of their child. Home education is a legitimate schooling option that some parents decide is the most appropriate option for their children at a given time in their learning journey.

The Education (General Provisions) Act 2006 (the Act) provides the legislative basis for home education regulatory processes and requirements, with the Department of Education's Home Education Unit overseeing home education registration processes and reporting requirements in line with the Act.

Home Education Unit Review

Between 2019 and August 2024, the number of children registered for home education rose from 3,411 to 11,314, an increase of 230 per cent. In 2025, approximately 11,400 Queensland children are registered for home education. After a period of home education, some children return to a state, or nonstate, school, or move between modes and sectors of education more than once.

The independent Home Education Unit (HEU) Review sought to understand the diverse experiences and needs of home educating families. In line with the review's Terms of Reference, market research heard directly from home educating families about their experiences of home education regulation and the challenges in providing school education at home. Of those who participated in the research, a significant proportion of respondents reported their home educated children have learning disabilities. Some parents became home educators due to their child's adverse experiences in a school environment. Some parents chose home education as it best suited their child's needs and circumstances. The Department of Education will continue to work with home educating families and the broader sector on how best to support children and young people in the delivery of education.

The HEU Review Final Report makes eight overarching recommendations focused on repositioning and enhancing home education governance in Queensland, modernising home education regulation, and support and advisory responses for families.

Reforms to Home Education support and communication

The Queensland Government supports recommendations of the HEU Review, and will take a progressive approach to implementation, starting with those that can be achieved via non-legislative measures. This includes the recommendations for enhancing communications and collaboration between the HEU and home education community members, and improving resources, and their accessibility, to support families fulfil regulatory obligations.

The HEU will be renamed as 'Queensland Home Education' to signal a new approach to better supporting home education for children and young people in Queensland. Further, the Department of Education will prioritise establishing an ongoing Queensland Home Education Consultative Group to enable continued and regular communication with families in undertaking these reforms.

These actions will assist progress on the review recommendations, all of which require further consideration, including stakeholder input to inform the best response and an approach to implementation.

The Queensland Government response to all recommendations is provided in the recommendations table below.

Out of scope matters

The HEU Review Final Report raised several out-of-scope matters. The Queensland Government is taking action to address the concerns raised about age eligibility for home education registration, pending consideration of legislation through the Queensland Parliament.

Further consideration and consultation is required with relevant stakeholders on observations made about: home education reporting time frames; oversight of students' movement in and out of state/non-state schooling and home education; partial enrolment in a school; number of home-educated children with learning difficulties, diagnosed disabilities, or mental health concerns; and unregistered families who home educate their children.
