Your opportunity

As the Boat Officer you will:

- Assist the Principal and other teachers in the delivery of a unique program of environmental education in coastal wetlands.
- Plan and implement a program of preventative maintenance of the boats and all centre equipment and carry out mechanical and shipwright repairs as required.

The Boat Officer reports to the Principal of the Centre. On board, the Boat Officer supervises passengers including visiting teachers, accompanying adults, student passengers and all other passengers.

Your role

Appointments in the public sector are merit-based and will be assessed by looking at what you have done previously—the knowledge, skills and experience you have built, your potential for development, and your personal qualities.

Responsibilities include:

- As Ship's Captain, command and operate boats as both an on board 'classroom' and as a means of transporting students to specific sites for environmental studies.
- Contribute to the education of students by:
 - Instructing students, teachers and accompanying adults in a range of skills, techniques and experiences relative to safe, intelligent boating in an educational setting, including:
 - Safety talks including rules, procedures and operations when boating and in associated environments.
 - Demonstrating and leading sampling and surveying of aquatic plant and animal life through netting, trapping and dredging and participating in a wide range of sustainable recreational fishing experiences.
 - General boating and water safety including how to operate and manoeuvre boats, radio operations, navigation and managing specialist equipment.



- o Planning, creating, developing and fabricating resource material and equipment associated with programs.
- Assisting with instruction and demonstration of components of centre programs under the supervision of teaching personnel.
- Assist with the development and maintenance of centre facilities, resources and aquatic/boating studies programs (including the Marine Centre) to enable programs to be conducted in a safe, supportive and productive learning environment.
- Operate and maintain plant, equipment, grounds and facilities in a healthy and safe condition. This includes, but is not restricted to, electric arc, MIG and TIG welders, oxy acetylene welding and cutting, offcut saws, power tools, motors (petrol, diesel and electric), tractors, mowers, whipper snippers, chainsaws and any special equipment used in the delivery of educational programs at the Centre.
- Collaborate in the development of all aquatic/estuary/boating studies programs to ensure full potential of the Centre's available resources and accessed environments is reached.
- Supervise the training of teachers in the correct operation of watercraft and assist them in attaining both recreational ship masters license and restricted/unrestricted coxswains license as required.
- Liaise with marine surveyors, marine architects and staff from other departments with regard to maintaining the boats to fulfil the Centre's needs.
- Liaise with government and non-government groups, businesses and individuals relating to catchment management programs, sponsorship of boating equipment and special projects/programs as well as general information and local knowledge vital to the effectiveness of the boating programs.
- Establish and maintain:
 - The administrative and financial operations of boating programs and marine vessels and equipment using the Centre's purchasing procedures while complying with the guidelines of the Centre's annual operating budget.
 - Log, register and record, as required, including vessel log books, coxswains log, survey and catch records, fuel and consumables records, engine maintenance records, safety drill registers and inventory stock surveys.
 - Periodic and preventative service/maintenance program for the Centre's vessels, motors and associated equipment including boat hulls, trailers, radios, personal flotation devices and other survey and non-survey requirements.
 - Monitor procedures and policies, ensuring they are updated to align with current standards of Government bodies, the Department of Transport, Department of Education, the Centre and the impacting environments.
- Collaborate in the development of both general and specific safety procedures and policies incorporating both legislated and centre based information (risk assessments, workplace health and safety, emergency procedures and drills).
- Liaise with government and non-government groups, businesses and individuals with regard to catchment management programs, survey needs, special projects/programs and boat maintenance and enhancement as well as general information and local knowledge vital to the effectiveness of the boating programs.
- Plan and undertake the fabrication of infrastructure as required to support boats associated with the development and expansion of boating as a major curriculum direction.
- In addition to the above boating activities, it is expected that the Boat Officer will assist with the broader range of
 programs and operations including maintenance of the Centre's grounds and facilities and undertake
 improvement and enhancement activities.

Other responsibilities (as required)

• Other suitable duties, consistent with the duties and responsibilities of the position as directed by the supervisor or nominated delegate.

A mandatory requirement of this role is:

- In accordance with the <u>Working with Children (Risk Management and Screening) Act 2000</u> a person is prohibited from working in regulated child-related employment unless the person holds a current Working with Children Check clearance (blue card) issued by Blue Card Services.
- Australian Maritime Safety Authority (AMSA) coxswain licence appropriately endorsed for local operations or Master 5 licence.
- A restricted radio operator's certificate of proficiency.
- A current Senior First Aid Certificate.
- A "C" class driver's licence.

Whilst not mandatory, documents demonstrating competency in any of the following areas would be highly regarded:

- Servicing, maintaining and repairing outboard motors, petrol and diesel-powered engines.
- Use of power tools and grounds care equipment and materials.
