- Information is based on live unvalidated OneSchool data as at 30 April 2021 and is for incidents occurring between 1 January 2020 and 27 April.
- Table 1** - provides a list of school disciplinary absences where the reason is defined as physical misconduct involving an object or conduct prejudicial AND the term knife is used in the free text. The contents of this table more likely conforms to the request - *incidents reported in OneSchool RESULTING in student suspension and/or exclusion involving a knife.*
- Table 2** - includes all other school disciplinary absences which include reference to a knife. For these incidents - the reference to knife is more likely incidental than the reason for suspension / exclusion. i.e. 'knife' is included as a verbal threat only or in association with the real reason for the SDA. An indicator of this could be where the SDA Reason for these incidents is *Verbal or Non Verbal Misconduct* or *Substance Misconduct*. An example could be:
"I am going to bring my Dad's pocket knife to school"
- Incidents leading to more than one student receiving an SDA are reported for each student's SDA.
